8.0 What is this Depth study about?

In 1913, the Russian Empire covered one-sixth of the world's land surface. That year the tsar, Nicholas II, celebrated the 300th anniversary of his family's reign. The Russian monarchy seemed very secure. However, five years later, Russia had been transformed by two revolutions. In 1917, the Provisional Government ruled for a few months, before communists seized power in November. The communist government was led by Vladimir Lenin until his death in 1924, then Joseph Stalin rose to power by 1929.

Despite these dramatic changes, many features of life in Russia remained the same. Society was still mostly rural. Many people in Russia described the economy as 'backward' because it had been left behind by the Industrial Revolution that swept the rest of Europe in the 1800s. Stalin ruled as a dictator, but in the years before 1941, the Union of Soviet Socialist Republics (USSR) was modernised, affecting the lives of millions of people.

After such a long period of stability, what caused Russia to have two revolutions in 1917? What were the consequences of these revolutions, and how were people's lives altered as a result?

Nicholas II (1868-1917)

Nicholas II became tsar in 1894 aged 26. He did not feel well prepared for political leadership but he was committed to autocracy, believing it was the best form of government for Russia. He was devoted to his wife, Alexandra, and to his children but was easily influenced and took advice from his wife and her favoured advisers. Nicholas believed that he needed to know the business of government in great detail, and often interfered in the work of his ministers. However, he did not really understand the extent of the social, political and economic changes that Russia needed. Nicholas lost the support of his government and his generals after 1915 and was forced to abdicate in March 1917. He and his family were shot by the Bolsheviks in July 1918, at a key point in the Russian Civil War.

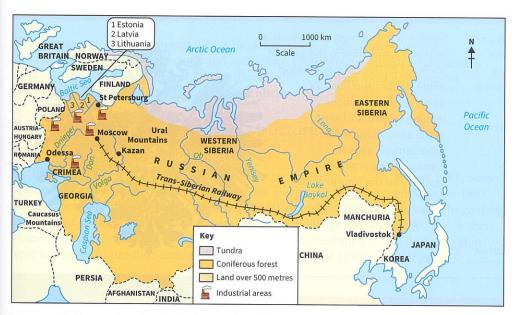


Figure 8.2: A map showing Russia's natural landscape, main cities and industrial centres before 1914

The Russian Empire

In 1914, the Russian Empire appeared strong, but its size slowed communications and its long borders exposed it to attack. Only 44% of Russia's population were ethnic Russians. Most Russians followed the Russian Orthodox Christian faith. The government, based in the capital, St Petersburg, was dominated by Russians, who tried to unite the empire through a process known as Russification. These policies were extremely unpopular, and many national minorities wanted greater independence. Persecution of Jewish people was particularly harsh, and the government even encouraged pogroms.

KEY TERMS

Russification: the official policy of forcing non-Russians to accept the Russian language and Russian rules in schools and in local government

pogroms: riots or semi-organised violence directed against Jewish people and their property

Tsarist government

Tsar Nicholas II was the head of an outdated system of government. He was the supreme ruler, holding all power and authority. He was a caring family man, but he was not an effective monarch and there was little coordination of policymaking. Unlike many other countries at the time, Russia had no political opposition and no elections, because there was no parliament.

Nicholas often took advice from his wife, Alexandra, in his dedication to maintaining the Tsarist regime. The tsarina was German by birth, and she did not speak Russian fluently. She was so shy that the royal couple avoided hosting social events, and they lacked support from the **aristocracy**, which made up 1.5% of the population but owned 25% of the land and held a lot of power.

Source 8C: The crest of the Russian monarchy and state in the time of Nicholas II. The double-headed eagle symbolised Russia's geographical position, looking to east and west at the same time. It also represented Tsarism's history and its intention to remain into the future.

The Tsarist system was supported by a huge **bureaucracy** across the country. Generally, the system was corrupt and inefficient. Government officials were usually members of the aristocracy, but some officials who controlled local government organisations (*zemstvo*) were reforming members of the **liberal intelligentsia**.

Russia's population and social structure

The peasantry

In 1900, around 80% of Russia's population were peasants, or **serfs**. Before 1861, peasants were the property of the landowners. Even after the serfs were freed in 1861, Russia's peasants had to pay for their land in 49 annual payments. This was a huge debt for many of them. The majority of peasants lived in village **communes**. Although there were some successful peasant farmers (*kulaks*), most continued to live on farms that were too small to produce enough food, and they suffered from land hunger.

KEY TERMS

bureaucracy:

a system for managing a country or organisation operated by a large number of officials who follow the rules very carefully

liberal intelligentsia:

a group of educated people (doctors, lawyers, teachers, writers and other professionals) who were active in political leadership. They became frustrated at the 'backwardness' of tsarism

serfs: peasants who were forced to work for a landowner. Serfdom was common in Europe in the Middle Ages, but Russia's system lasted longer than in most other places

commune: a

community of people who live together and share property, resources and labour

kulaks: wealthier peasants (the word 'kulak' means 'fist' or 'tight-fisted': mean with money)

Government control

The government's response to political problems was almost always to repress rather than to reform. Opposition parties were illegal, and political dissenters were executed or sent into exile in Siberia or abroad. The government's methods of control were generally very effective.

- The Okhrana was formed to combat anti-government activity. It used techniques such as spying, opening mail, bugging rooms and tapping telephone lines.
- Laws gave police and local governors emergency powers to arrest and imprison suspects, to close down and fine newspapers, to shut down local parliaments, and to control what was published.
- The army was regularly used to control the population, especially the peasantry.
- Since the government lacked a network of state control in many areas, it relied heavily upon the Russian Orthodox Church. The Church used its spiritual authority to teach the Russian people that obedience to the tsar was their duty.
